12.0 Public Hearing: To Receive Public Input for the Development of a Grant Proposal for Funding from the 2012-2013 California Off-Highway Motor Vehicle Recreation Division Grants and Agreements Program to Improve Off-Highway Motor Vehicle Route Access on Forest Service Roads in the South Fork and Trinity River Management Units of the Shasta-Trinity National Forest.

Paul Hart, OHV coordinator for Shasta-Trinity National Forest noted the new Travel Management Map for STNF will be available March 1. Blanchard explained the District will be applying for a grant to brush approximately 26 miles of forest roads in four areas of STNF. Those areas are Corral Creek, Clark/Eltapom Creek, Hyampom and Plummer Creek. The grant will be matched by stormproofing of roads through the USFS Legacy Roads project. Hart noted this larger percentage of match confers greater competitiveness to the grant application. The maximum possible is \$1.5 million. TCRCD plans to request \$30,000 although its potential match is much higher. Blanchard noted current work obligations this season preclude expanding this proposal request significantly for 2013. No members of public present for hearing.

USDA Rural Development can assist with biomass facilities. USFS is funding the preliminary expenses of organizing the collaborative.

MINUTES OF APRIL 17, 2013

Directors reviewed draft three-year operational agreement with NRCS. John George explained the pending vehicle agreement currently in revision is referenced in operational agreement. He has applied for funds for CCC to repair a dike at Weaverville Basin Wetlands so it does not wash out.

George noted \$1.1 million initially allocated for EQIP in Trinity has been cut to \$850,000 and Assistant State Conservationist Jim Spear is working to have the full amount reinstated. George requested and obtained an additional \$250,000 for forestlands work in Trinity, separate from the EQIP allocation. He noted such funding is needed for a multi-year span in order to accomplish needed work. George noted his replacement will probably be selected and in position by end of June.

7.0 Northwest California RC&D Council Report

Truman reported the Council met in Eureka the previous week.

8.0 Community Forest/Stewardship Committee Report

Cousins reported the BLM-RAC is planning for a quarterly meeting June 11-13.

9.09.0 Trinity County Collaborative – USDA Report

Cousins reported the recent meeting in Hayfork had 76 participants and almost all stayed for six hours working to establish organizational structure. He explained the procedure in place to ensure minority opinions are aired and considered by the group. Considerations include where and when to hold meetings to accommodate all who want to participate. A draft charter will be presented at the next meeting, May 3 in Weaverville. The subsequent meeting will likely be in Hayfork on May 17.

10.0 Trinity County Trails Report

The District has two crewmembers working on trails and is eliciting input from public on where trail work is needed.

Cousins noted there is also a need to address job status when an employee's driver's license is revoked. The District's ability to get work done suffers significantly when an employee can no longer drive or is no longer insurable by the District's carrier. Response needs to be consistent. In instances where job description requires driver's license, employee should be bumped down to lower level classification not requiring license. A stipend for supervisory responsibilities could be paid where appropriate. Cousins will come back with proposal that reflects need for CDL plus insurability by District's carrier.
